#### **Weapons Stance**

A few months ago, an episode occurred at the Credit Union that led to us temporarily declaring our branches as weapons free zones. This action led to a small but passionate response from some of our members that disagreed with this change. After taking these opposing views into consideration, the Credit Union's Board and Management decided to reverse our earlier decision to ban concealed weapons at our branches.

One of the arguments made against weapons free zones was that these bans may actually increase the likelihood of a criminal event because the criminal will feel safer in a weapons free area. Although it's debatable whether someone intending to commit such a high risk/low reward crime as armed robbery would think logically enough to consider whether someone with a concealed weapon may be present when they choose to commit that crime, a reasonable argument could be made either way.

In the future, Credit Union employees will make safety related decisions on a case by case basis. If an employee feels threatened, whether it be from seeing a visible weapon or for any other reason, they will contact authorities as soon as it's safe to do so. When authorities receive incident requests from financial institutions, they treat these calls as real threats. If they see visible weapons, they will act as if lives are in danger and that the weapon holder poses a threat, regardless of the weapon holder's intent. Doing otherwise could put their lives and the lives of bystanders in danger. The Credit Union's Board and Management will back this employee decision, regardless of whether the perceived threat was real or imagined. The reason behind this level of support is that the potential consequence of underestimating such threats is too high.

Unfortunately, society has changed to where threats to safety are becoming much too common. In the areas we serve, we have seen an increase in robbery attempts and violence over the past few years. Unlike in the past, we're not immune to these threats just because we live in a rural area.

As always, our primary concern is to provide a safe and stable place for our members to conduct their financial business and for our employees to serve them.
