
WOULD YOU LIKE TO SERVE ON OUR BOARD OF DIRECTORS?

In the financial services industry, the NPS (Net Promoter Score) has empirically proven to be the best indicator for future business success. By filling out the survey, we can determine if our members would recommend our products/services and find areas of overall improvement at the credit union. The average NPS provided by bank customers across the country is 35. The average NPS for credit unions is 56. PFCU scored significantly higher with an NPS of 74.
